

Terms of Use

Introduction

Welcome to Princeton CryoTech! This Terms of Use Policy (“Terms of Use”) applies to this website and any other websites or mobile applications, together with the information, resources, services, products, and tools (“the Services”) owned and/or operated by Princeton CryoTech, Inc. (“Princeton CryoTech” “we” “us” “our”). By visiting and accessing the Services we provide, you understand and agree to accept and adhere to the following terms of use as stated in this policy, along with the terms of our Privacy Policy.
